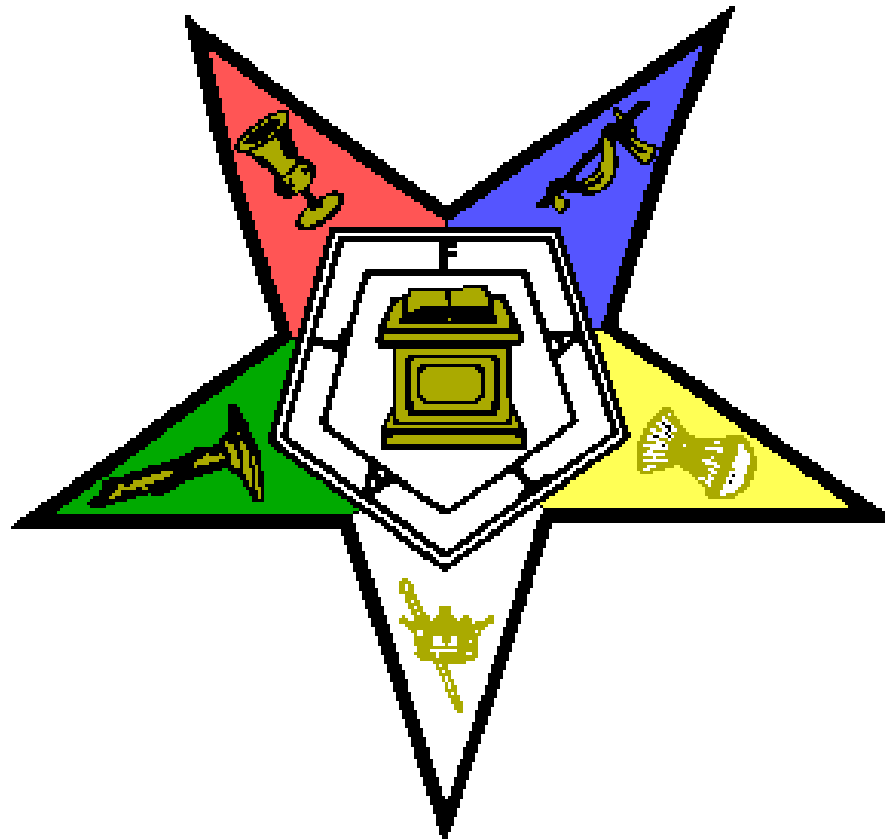


Order of the Eastern Star PHA
